Behavioral Health Home (Formally known as "case management") is an alternative to traditional case managemen Behavioral Health Homes is a collaborative approach to providing you with a comprehensive plan of care designed by your behavioral health and medical providers. This is a MaineCare funded service designed to help you manage your behavioral and physical health needs more effectively. The BHHO has a comprehensive behavioral health tea that will support you in your journey to a healthier life. Inquire about our Free Care Program for uninsured clients who need help too!

"Counseling" or outpatient therapy is utilized by individuals who seek to make a change or adjust to a change in their life, but need some guidance or support in doing so. We use a collaborative process, involving a non-judgm tal, supportive counselor who works with a client to tell their story, identify what they want to change, sett viable goals and develop the strategies necessary to accomplish their goals. We work with our clients in making change in the way they think, feel, and behave. We work with our clients on developing healthy copings, healthy relationships and a healthier life for themselves. For some people this process takes a few visits, but for others, the process will take much longer. We will support you in reaching your goals independently; or, with your appro-, we can involve family members or significant others.

Behavioral Health Home (BHH)- Although "home" is included in the name, it is not a residential service. While sim to traditional Case Management, we utilize a multidisciplinary team. This team recognizes the importance of balancing both your physical and mental health. We work closely with your Primary Care Provider to ensure continuity of medical care in additional to addressing your mental health symptoms.

Community Integration Case Management (CI) This is the traditional Case Management model. Availability of this service is limited and requires meeting eligibility criteria. This will be explained during the intake process. You will work one on one with your case manager and create an Individualized Service Plan which will guide treatment.

Assertive Community Treatment (ACT) differs from case management services in that a medical/psychiatric component is added to the case management team, with a half-time psychiatrist and one psychiatric nurse providing twenty-four hour a day/seven day a week service capability. The Team also has four clinical community support workers, a vocational specialist, and a dual diagnosis/substance abuse specialist

It is the goal of Counseling Services to provide the opportunity and resources to support this goal and maximize the prospects for long-term healthy functioning and quality of life. Counseling Services embrace an underlying belief that everyone is capable of positive changes and that change happens in stages. Counseling Services acknowledg differences in the individual's resources and readiness for change and strive to respond accordingly with the most appropriate treatment. Counseling Services offers a sliding fee scale based on income eligibility and accepts many private insurances, MaineCare, Medicare, and self-pay by the client.

support in increasing their independence in everyday life. Case managers support clients through linking them to needed services such as mental health support, medical care, housing services, transportation, education, and employment opportunities. Case managers seek to support clients who are struggling with mental health condition to become more independent in their communities and more able to navigate the systems with which they engage

in their everyday lives, such as DHHS, Mainecare, FedCap, and the like.

Gateway's counseling program serves clients of all ages, and clinicians can see clients in their homes, the community, or in the traditional office setting. Clinicians are adept at addressing both mental health and behavior health concerns. Common issues that we work on in counseling include helping clients learn to cope with and more past traumatic experiences, managing anxiety, overcoming depression, learning anger management, and dealing with problematic interpersonal relationships. **Note: Do NOT accept clients with Medicare insurance for

counseling.**

Personal Support Specialist (PSS), also known as Personal Care Assistant (PCA), is an individual who provides inme Personal Care Services to both the elderly and disabled adult population throughout Maine. The PSS/PCA provides hands-on assistance with tasks of daily living. In order to qualify for PSS services, you must either contact your primary care provider or Maximus and request an assessment. Once you complete your assessment you will be assigned a Care Coordinator and will be placed on the statewide waitlist.

The Case Management program provides a full range of services to people with developmental disabilities, includi advocacy, referrals, and connections to local resources. Geriatric Case Management is available for clients eligible for MaineCare and who have a mental illness diagnosis (Axis I or 2, GAF 50 or less) or consent decree member

Maine Behavioral Healthcare's Assertive Community Treatment (ACT) is an intensive community based (outpatier treatment program with a multi-disciplinary team of providers that supports MaineCare eligible adults who may have a major mental illness diagnosis and often co-occurring disorders. The goal of the ACT Program is to improve the client's functioning in the least restrictive setting, while strengthening family, work, school and community ties

Elderworks is a day support program that provides group therapy services to older adults with chronic mental illner. Through this program, clients are able to engage with one another and individually with clinicians, while learning how to cope with depression, anxiety, isolation, and social stigma.

Clinicians and Case Managers fluent in American Sign Language provide mental health services to deaf and hard chearing, deaf-blind, and late deafened adults and children in a deaf-culture friendly program. The team serves people throughout Maine, as well as family members of deaf individuals.

developmental disability diagnoses. The Community Supports Program offers daily activities and skill building

assistance to adults with mental retardation or an autistic disorder.

MVRA offers Mental Health Case Management services to adults 18 years and older. MVRA assists in connecting people to the appropriate place to receive a mental health evaluation if an Axis I diagnosis is not already documented.

Eligibility: 18 years and older, MaineCare eligible, MR or autism diagnosis and have adult services case manager MVRA will assist individuals in obtaining MaineCare, diagnosis and case managers if needed for intake. Transportation can be arranged to the facility through RTP.

MVRA provides professional assessments, counseling, and therapeutic services. These services are provided to individuals seeking to improve functioning, address symptoms, relieve excess stress, and promote positive orientation and growth. The goal of these services is to increase integrated and independent levels of functioning. Services are individualized, in accordance with an Individualized Treatment Plan. Services may include, and are n limited to, a comprehensive assessment, diagnosis, and individual therapy. Services are provided by licensed clinicians.

MVRA's Employment Support Services provides trained employment specialists & job coaches to assist people witl disabilities or barriers to employment find and keep a job. All referrals come from the state Dept of Vocational Rehabilitation; must be MaineCare eligible.

Daily Living Skills - provides therapeutic supports to assist individuals with difficulty integrating into and accessing the community of their choice. They support individuals in developing and maintaining skills of daily living and independence.

The Behavioral Health Home (BHH) delivers integrated care to people who struggle with mental health. Intent is I involve each client in their own care, so that they will be able to achieve the level of health and wellness that they desire and maintain this success on their own. BHH care coordinators help clients consider their needs around housing, health care, finances, work, education, social and recreation time, and other areas that are important to them. Together clients and care coordinators use this information to develop a treatment plan made up of individual goals and preferences. Adult residents of Cumberland County (18 and over) who have been diagnosed with a mental illness and who are covered by categorical MaineCare.

Gordon Green: An eight-bed permanent residence providing intensive treatment and support for elderly adults under guardianship with a combination of challenges including mental illness and disabilities related to age or physical impairments.

Helen Winslow Ray House: A seven-bed comprehensive rehabilitation residence providing support, counseling and advocacy for adults with a major mental illness.

Morrison Place at Randall Street: This 12-bed facility, serving homeless men and women from across the state offers intensive individualized treatment, education around mental health diagnosis and the complexities of co-occ ring disorders, coping skills to help manage symptoms, and relapse prevention skills such as anger management, conflict resolution, ADL skills, and transitional living skills.

Broadway Crossings: Adult Crisis Stabilization Unit, with a capacity of eight adult beds, is a short-term crisis stabilization unit providing a consumer-friendly alternative to hospitalization that allows people to remain connecte to their support networks in the community.

Opioid Health Home (OHH) is an office/community-based program that exists to support optimal service delivery individuals living with opioid use disorder by offering Medication for Opioid Use Disorder (MOUD), clinical counselicase management, nurse care management and peer support.
