

The Medicare Savings Program (MSP) helps pay monthly Medicare premiums and out-of-pocket costs. People who are eligible for Medicare Part A may qualify for MSP.

There are two levels of MSP coverage. Eligibility depends on monthly income.

Depending on household income, MSP can help pay:

- Medicare Part B monthly premiums (physician and other medical care)
- Certain Medicare deductibles and co-pays and co-insurance

People with MSP qualify for the Extra Help Program which helps by lowering:

- Medicare Part D monthly premiums (prescription drugs)
- Medicare Part D Donut Hole costs
- Medicare Part D out-of-pocket costs

A person who qualifies for this coverage is referred to as a Qualified Medicare Beneficiary (QMB).

Some people with higher income may qualify for help paying for Medicare Part B and Part D premiums, and the Part D donut hole and deductible. People who qualify for this level of help are referred to as Qualified Individuals (QI).

The monthly income limits for the Medicare Savings Program (QMB and QI) are below. Some income can be reduced when applying for MSP (for example \$75 for a single person or \$100 for a married couple can be deducted).

	Monthly Income Limits

Single	\$2,322	\$3,138
Couple	\$3,152	\$4,259

There is no asset test or estate recovery requirements for the Medicare Savings Program.

Married couples with income greater than the amounts listed above may still be eligible. \$472 may be deducted from the income of the spouse who has lower medical costs to reduce the couple's income.

MSP waives Medicare lifetime penalties (higher premiums due to late enrollment in Medicare may be reduced).

<u>Maine's Drugs for the Elderly Program</u> (DEL) helps with medication costs for older Mainers (age 62 and over) and Mainers (age 19 and older) with a disability.
